We are pleased to inform you that at its meeting last month, the ARZA Board voted an allocation of \$22,000.00 to Garin Galil. Since our allocations are a percentage of our dues income, this amount might vary slightly depending on the actual income that we receive.

We have informed Fred Cohen that \$11,000.00 of this amount will be available to you by the middle of May, and the remainder will be available as of July 1.

The reason for this allocation, of course, is the tremendous importance that we attach to aliyah in general and to your settlement in particular. You are doing work of great significance to our movement, and we hope that our contribution will be helpful in making Har Halutz a reality.

We will need an accounting of how the money is spent, and we would appreciate it if you would identify ARZA as a sponsor of Har Halutz in all of your literature.

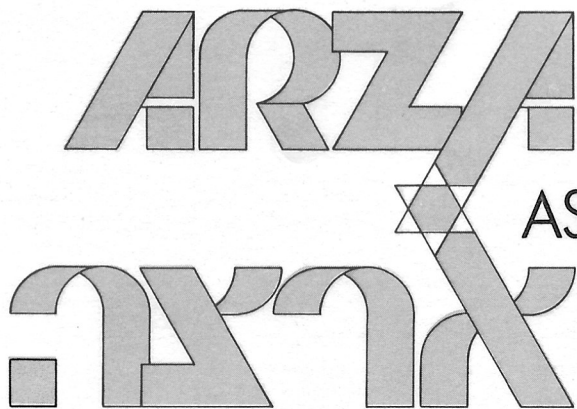
